WHEREAS, Section 16 of RA 7160, otherwise known as the Local Government Code of 1991 provides that, "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, xxx";

WHEREAS, Section 17 of the same Code, provides that, "Local Government Units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them, xxx Local Government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein, "such as the upgrading and modernization of tax information and collection services through the use of computer hardware and software and other means";

WHEREAS, there is a program from the National Computer Center (NCC) under the Department of Science and Technology (DOST) providing free computer applications to Local Government Units which include the Treasury Operations Management System, Real Property Tax System and Business Permit and License System;

WHEREAS, one of the requirements in order for a Local Government Unit to be a beneficiary of the said program is the passage of a resolution manifesting the intent of the former to avail of the free application systems from the National Computer Center;
