ORDINANCE NO. 04-007

AN ORDINANCE REQUIRING ALL CINEMA OWNERS/OPERATORS OPERATING WITHIN THE CITY OF MUNTINLUPA TO INCREASE THE PRICE OF THEIR MOVIE TICKETS BY ONE PESO (P1.00) COVERING THE PERIOD FROM NOVEMBER 01 TO DECEMBER 31, 2004 TO SUPPORT AND IMPLEMENT THE PROGRAMS AND ACTIVITIES OF THE BOY SCOUTS OF THE PHILIPPINES, METRO MANILA SOUTH COUNCIL.

WHEREAS, the Boy Scouts of the Philippines, Metro Manila South Council passed Resolution No.01-2004, dated June 1, 2004 requesting Honorable Mayor Atty Jaime R. Fresnedi thru Honorable Vice Mayor Aldrin L. San Pedro and the Muntinlupa City Council to pass an ordinance requiring all cinema owners and operators to increase their prices of movie tickets by two pesos (P2.00) in Muntinlupa City covering the period from August 1 to October 30, 2004 and every year thereafter to support and implement the programs and activities of the Boy Scouts of the Philippines, Metro Manila South Council;

WHEREAS, the BSP, Metro Manila South Council, a highly urbanized entity, which comprises the cities of Muntinlupa, Las Piñas, Parañaque and Pasay and municipalities of Pateros and Taguig in the South District of Metro Manila has identified the main duties and obligations of the Scout and these are: Duty to God and Country, Duty to Others and Duty to Self:

WHEREAS, to achieve these noble objective, the BSP Metro Manila South Council has lined up several scouting programs and projects designed to prepare the boys as catalyzers and community development leaders and advocates of services pursuant to its scouting motto" Laging Handa" and scouting slogan "Do a Good Turn Daily";

WHEREAS, the present Headquarters of the BSP, Metro Manila South Council is in dire need of office tables and chairs, steel cabinets with vault, office equipment such as overhead projector, computer to improve its communication facilities especially in pursuance of training workshop and other related services geared towards the wholesome and total development of boys in the South District of Metro Manila, such as attending the BSP National Jamboree on December 27, 2004 to January 3, 2005 at Mt. Makiling, Los Baños, Laguna;

WHEREAS, the BSP Metro Manila South Council cannot do this tremendous responsibility alone without the assistance of the City and the prominent civic leaders in the various sectors of society;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Muntinlupa that:

Section 1. This Ordinance requires all cinema owners/operators operating within the City of Muntinlupa to increase the price of their movie tickets by One Peso (P1.00) covering the period from November 01 to December 31, 2004 to support and implement the programs and activities of the Boy Scouts of the Philippines, Metro Manila South Council.

For this purpose, the City Treasurer is hereby mandated by this Ordinance to prepare the implementing guidelines relative to the manner of collection and remittance to be followed by all cinema owners/operators, within three (3) days after approval of this Ordinance.

Copy of this Ordinance shall be posted to every cashier's booth of the cinemas and shall inform moviegoers about it.

Section 2. All movie tickets to be sold by the cinema owners/operators shall be properly numbered and stamped by the City Treasurer's Office.

Section 3. This Ordinance shall take effect upon its approval and only within the covered period.
