AN ORDINANCE AMENDING ORDINANCE NO. 03-117, OTHERWISE KNOWN AS "AN ORDINANCE IMPOSING FRANCHISE TAX ON BUSINESS ENJOYING A FRANCHISE TAX AT THE RATE OF SEVENTY FIVE PERCENT (75%) OF ONE PERCENT (1%) OF THE GROSS ANNUAL RECEIPT FOR THE CALENDAR YEAR BASED ON THE INCOMING RECEIPT OR REALIZED BY SUCH BUSINESS".

WHEREAS, the Third Sangguniang Panlungsod passed Ordinance No. 03-117 last October 23, 2003 imposing franchise tax on business enjoying a franchise tax at the rate of seventy five percent (75%) of one percent (1%) of the gross annual receipt for the calendar year based on the incoming receipt or realized by such business;

WHEREAS, the City Finance Committee approved a resolution recommending to amend the Ordinance to provide for an effectivity date on *January 1, 2005*;

WHEREAS, the City Treasurer and the Business Permit and Licensing Office cannot impose the said Ordinance as yet because there is no provision on the effectivity date;

WHEREAS, in order that the City Treasurer may be able to collect the franchise tax, without legal impediment or question, it is imperative that a City Ordinance provide for effectivity date on when to collect the said franchise tax;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of Muntinlupa assembled that the effectivity date of the collection of Franchise Tax or the implementation of the said Ordinance No. 03-117 shall be on January 1, 2005.

ENACTED, by the Fourth (4th) Sangguniang Panlungsod of Muntinlupa this 16th day of September 2004, on its 11th Regular Session.
