ORDINANCE NO. 04-012

AN ORDINANCE GRANTING THREE THOUSAND PESOS (P3,000.00) TO EVERY HOMEOWNER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND TWO THOUSAND PESOS (P2,000.00) TO EACH RENTER, BOARDER, SHARER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND ONE THOUSAND PESOS (P1,000.00) TO EACH HOMEOWNER, RENTER, BOARDER, SHARER (WHOSE HOUSE WAS PARTIALLY DAMAGED).

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that *"The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

"(1) (iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"

WHEREAS, on *October 7, 2004*, there were seventeen (16) homeowners (whose houses were totally damaged), ten (10) renter (whose house were totally damaged), four house sharers and three house boarders (whose house were totally damaged) and six (6) house owners (whose house were partially damaged) who were affected by the fire in *Arciaga Compound, Quezon St., Bukal, Poblacion Muntinlupa City*;

WHEREAS, the owner of the houses, renter, sharers, and boarders, were rendered homeless by reason of the said fire;

WHEREAS, there is need for the City Government to give financial assistance to the aforesaid victims in the amount of *Eighty Eight Thousand Pesos (P88,000.00)* to be distributed as follows:

Houses/Homeowners	Total No. per family	Amount
House owner (totally damaged)	16 x P3,000.00	P48,000.00
House owner (partially damaged)	6 x P1,000.00	6,000.00
Renter (totally damaged)	10 x P2,000.00	20,000.00
House sharers (totally damaged)	4 x P2,000.00	8,000.00
House boarders (totally damaged)	3 x P2,000.00	6,000.00
TOTAL		P88,000.00

WHEREAS, The *Social Services Department* of the City has submitted a certified copy of the list of the homeowners (totally damaged) and renters, sharers and boarders in coordination with the Barangay Chairman of Poblacion, Hon. Alexander Diaz and is made an integral part of this Ordinance;

WHEREAS, there is an available fund from the Calamity Fund in the 2004 Executive Budget of the City;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled to grant Three Thousand Pesos (P3,000.00) to every homeowner (whose house was totally damaged), Two Thousand Pesos (P2,000.00) to each renter, boarder, sharer (whose house was totally damaged and One Thousand Pesos (P1,000.00) to each homeowner renter, boarder, sharer (whose house was partially damaged).

APPROVED, by the *4th Sangguniang Panlungsod of Muntinlupa* this *7th* day of *October 2004*, on its *13th* Regular Session.
