WHEREAS, Section 458, (a) (2) (i) of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod to enact ordinances in order to generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the city, with particular attention to city-wide growth and progress, and relative thereto, shall:

“(i) Approve the annual and supplemental budgets of the city government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants”;

WHEREAS, there is a need to allocate such fund in order to implement the different programs and projects of the City Government as stated in the Supplemental Budget of Funds Actually Available for the Fiscal Year 2004, as prepared by the City Budget Office;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod in session assembled that:

Section 1. This Ordinance hereby approves the 2004 Supplemental Budget amounting to Fifty Four Million Nine Hundred Seventy Nine Thousand Twenty Four Pesos (P54,979,024.00), which is breakdown as follows:
