WHEREAS, Section 17, Article II of the Constitution of the Philippines states that "*The State shall give priority to xxx technology xxx to accelerate social progress, and promote total human liberation and development*";

WHEREAS, Section 12, Article XIV of the Constitution of the Republic of the Philippines provides further that "*The State shall xxx promote the adaptation of technology from all sources for the national benefit. It shall encourage the widest participation of xxx local government in the generation and utilization of xxx technology*";

WHEREAS, computerization of police records and clearances is an advance technology, innovation and services which is essential to the development and progress of the City;

WHEREAS, there is a need for the computerization of police records and clearances to have an easy access to persons having criminal or derogatory records and for the easy apprehensions of convicted persons or suspects;

WHEREAS, there is also a need for the computerization of police records and clearances so that applicants may secure the same within a day from date of application;

WHEREAS, the fees to be collected for police records and clearances is based on the existing money being collected;

**NOW, THEREFORE, BE IT ORDAINED** by the Sangguniang Panlungsod of Muntinlupa in session assembled that:

Section 1. This Ordinance hereby mandates the computerization of police records and clearances in the City of Muntinlupa.

Section 2. The Head of the Management Information System (MIS) and the Chief of Police of Muntinlupa City are mandated to prepare the necessary guidelines for the implementation of this Ordinance.

Section 3. Any ordinance, resolution or rules inconsistent with the provision of this Ordinance is hereby repealed or modified accordingly

Section 4. This Ordinance shall take effect on 2005.
