AN ORDINANCE AMENDING ARTICLE VII, SECTION 8 (TRAFFIC GENERATORS) OF ORDINANCE NO. 02-047, OTHERWISE KNOWN AS THE ZONING ORDINANCE OF THE CITY OF MUNTINLUPA.

WHEREAS, Section 458 (a) (2) (vii) and (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod to adopt a comprehensive land use plan for the city and prescribe reasonable limits and restraints on the use of property within the jurisdiction of the city;

WHEREAS, it has been observed that the parking spaces requirements to all traffic generating building and structures as required under the Zoning Ordinance of the City of Muntinlupa is no longer adequate and suitable to meet the needs of the investors and would-be investors of the City, thereby affecting not only its business status but also its economic stability:

WHEREAS, as per request of the Filinvest Alabang, Inc., the City Planning and Development Office endorsed to the Sangguniang Panlungsod its recommendation for the amendment of Article VII, Section 8 (Traffic Generators) of Ordinance No. 02-047, otherwise known as the Zoning Ordinance of the City of Muntinlupa;

WHEREAS, there is a need to amend Article VII, Section 8 (Traffic Generators) of the Zoning Ordinance in order to meet the demands of the public and invite more investors to invest their business within the City.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Muntinlupa in session assembled that:

This Ordinance hereby amends Article VII Section 8 (Traffic Generators) of Ordinance No. 02-047, otherwise known as the Zoning Ordinance of the City of Muntinlupa, as follows:

If for any reason, any part or provision of this Ordinance shall be declared unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

All ordinances or part/s thereof which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

This Ordinance shall take effect ten (10) days after its approval and after publication in any newspaper of general circulation of the City.
