WHEREAS, on *October 7, 2004*, there were sixteen (16) homeowners (whose houses were totally damaged), ten (10) house renters, four (4) house sharers, three (3) house boarders (whose house were totally damaged) and six (6) house owners (whose houses were partially damaged) who were affected by the fire in *Arciaga Compound, Quezon St., Bukal, Poblacion, Muntinlupa City*;

WHEREAS, the owners of the houses, renters, sharers and boarders were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas as in a state of calamity;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the area affected by the fire last *October 7, 2004* at *Arciaga Compound, Quezon St., Bukal, Poblacion, Muntinlupa City* be declared as in a *State of Calamity*.

APPROVED by the *4th* Sangguniang Panlungsod of Muntinlupa this *7th* day of *October 2004*, on its *13th* Regular Session.






