### **ORDINANCE NO. 04-133**

AN ORDINANCE GRANTING THREE THOUSAND PESOS (P 3,000.00) TO EVERY HOMEOWNER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND TWO THOUSAND PESOS (P 2,000.00) TO EACH RENTER, BOARDER, SHARER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND ONE THOUSAND PESOS (P1,000.00) TO EACH RENTER, BOARDER, SHARER (WHOSE HOUSE WAS PARTIALLY DAMAGED) AFFECTED BY THE FIRE ON FEBRUARY 24, 2004 AT BISIG TRAMO, PUROK 5, PUTATAN, MUNTINLUPA CITY AND ALLOCATING ONE HUNDRED THIRTY SEVEN THOUSAND PESOS (P137,000.00), WHICH AMOUNT SHALL BE TAKEN FROM THE 2004 EXECUTIVE BUDGET - CALAMITY FUND.

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shalf

"(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"

WHEREAS, on February 24, 2004, there were twenty four (24) homeowners (whose houses were totally damaged), five (5) house owners, renters, sharers, boarders (whose houses were partially damaged), thirty (30) house renters/sharers/boarders (totally damaged) by the fire in Bisig Tramo, Purok 5. Putatan, Muntinlupa City,

WHEREAS, the owners of the houses, renters, sharers, and boarders,

were rendered homeless by reason of the said fire;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims in the amount of One Hundred Thirty Seven Thousand Pesos (P137,000.00) to be distributed as follows:

Renter/Boarder/Sharer (totally damaged)	30 x 2,000.00	60,000.00
House owner/Renter/Sharer/Boarder (partially damaged)	5 x 1,000.00	5,000.00
TOTAL:		137,000.00

**WHEREAS**, the Social Services Department of the City has submitted a certified copy of the list of the homeowners (totally damaged) and renters, sharers and boarders in coordination with the **Barangay Chairman of Putatan**, **Hon. Danilo R. Teves** and is made an integral part of this ordinance;

**WHEREAS**, there is an available fund from the Calamity Fund in the 2004 Executive Budget of the City;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled to grant Three Thousand Pesos (P3,000.00) to each homeowner (whose house was totally damaged) Two Thousand Pesos (P2,000.00) to each renter, boarder and sharer (totally damaged) and One Thousand Pesos (1,000.00) to each renter, boarder and sharer (partially damaged) affected by the fire on February 24, 2004 at Bisig Tramo, Purok 5, Putatan, Muntinlupa City, and allocating One Hundred Thirty Seven Thousand Pesos (P137,000.00), which amount shall be taken from the 2004 Executive Budget – Calamity Fund.

APPROVED, by the Sangguniang Panlungsod of Muntinlupa this 4<sup>th</sup> day of March 2004, on its 107<sup>th</sup> Regular Session.
