AN ORDINANCE GRANTING THE PRELIMINARY APPROVAL FOR LOCATIONAL CLEARANCE AND DEVELOPMENT PERMIT OF INTEGRAL REALTY CORPORATION LOCATED AT LOT 1, DON MANOLO BOULEVARD, ALABANG HILLS, CUPANG, MUNTINLUPA CITY.

WHEREAS, *Integral Realty Corporation* is applying for Locational Clearance and Development Permit for its townhomes project located at Alabang Hills, Cupang, Muntinlupa City;

**WHEREAS,** City Ordinance No. 91-39 grants the Sangguniang Panlungsod the power to approve subdivision plans;

WHEREAS, under Executive Order No. 71 and Republic Act No. 7160, otherwise known as the New Local Government Code of 1991, "the power of the Housing and Land Use Regulatory Board (HLURB) to approve preliminary and final subdivision plans of all subdivisions has been transferred to the Local Government Units";

WHEREAS, after evaluating the necessary documents submitted by Integral Realty Corporation and based on the recommendation of the City Zoning Administrator, the application for Preliminary Approval and Locational Clearance and Development Permit of the proposed townhomes project is hereby approved;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod in session assembled that:

**SECTION 1.** The townhomes project shall contain a total land area of 3,286 square meters only located at Lot 1, Don Manolo Boulevard, Alabang Hills Village, Cupang, Muntinlupa City.

**SECTION 2.** The issuance of Preliminary Approval and Locational Clearance and Development Permit shall be done provided the Environmental Compliance Certificate shall be secured from the Department of Environment and Natural Resources.
