AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN MUNTINLUPA TO INCREASE THE PRICES OF THEIR ADMISSION TICKETS BY ONE PESO (P1.00) COVERING THE PERIOD FROM JUNE 1 TO DECEMBER 31, 2005 TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE METRO MANILA PHILIPPINES COUNCILOR'S LEAGUE.

SECTION 1. All cinema owners and operators in Muntinlupa City are hereby required to increase their theater admission fees by One Peso (P1.00) covering the period from June 1 to December 31, 2005.

SECTION 2. All proceeds of this fund raising shall be used solely to finance the programs and activities of the Metro Manila (Philippines) Councilor's League (MMPCL) and a corresponding financial report shall be submitted to the City Council of Muntinlupa for its information.

SECTION 3. Senior Citizens shall be exempt from paying the additional One Peso (P1.00) imposed herein.

SECTION 4. This Ordinance shall take effect immediately upon its approval.


