WHEREAS, Section 192 and 458 (a) (2) (xii) of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that: "Local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary";

WHEREAS, on September 27, 2004, Ms. Katlhleen O.Guidote, President-Elect of SERRA International, SERRA Cllub of Makati sought the approval of the City Government of Muntinlupa, thru the Sangguniang Panlungsod for tax exemption of their fund-raising concert at Insular Life Building, Alabang, Muntinlupa City on November 9, 2004;

WHEREAS, the organizer of the musical concert, the SERRA Club of Makati located at #357 Sen. Gil Puyat Avenue, Makati City, is a member of the SERRA International whose mission is to foster and promote vocations to the priesthood and religious life. Its activities include, but not limited to spiritual growth in Christ, encouragement of church vocations, responsive lay leadership and coordinating financial support to the clergy, seminarians and seminaries in need;

WHEREAS, while it is admitted that the SERRA International, Serra Club of Makati is not registered under the SEC nor accredited by any local government, yet a mayor's permit and solicitation permit from Social Services Department (SSD) were issued for its fund raising concert entitled "Ama Mi";
