WHEREAS, Section 93, (a) for employment, scholarship, study grant or other purposes not herein specific, Article IV, Chapter II, Title IV of Ordinance No. 02-076 from PhP10.00 to PhP120.00, is hereby amended;

WHEREAS, Section 93, (b) for Firearms Permit Application and Section 93 (c) for Change of Name, Article IV, Chapter II, Title IV of Ordinance No. 02-076 both from PhP30.00 to PhP120.00, is hereby amended;

WHEREAS, Section 93, (d) for Passport or Visa Application, Article IV, Chapter II, Title IV of Ordinance No. 02-076 both from Php40.00 to PhP120.00, is hereby amended;

WHEREAS, Section 93, (e) for Application for Filipino Citizenship, Article IV, Chapter II, Title IV of Ordinance No. 02-76 from PhP150.00 to PhP260.00, is hereby amended;

WHEREAS, the rational given for the proposed increase is the recent computerization in the processing of *Police Clearance Certificates*, which entails additional expense for operation and maintenance;

WHEREAS, the proposed increase appears reasonable and warranted considering the actual costs involved in the processing of said *Police Clearance Certificates*, which is borne and shouldered exclusively by the City Government.

WHEREAS, the increase in fees should therefore go to the City Government, to be paid directly to the City Treasurer, pursuant to the Revised Revenue Code of Muntinlupa City, while the share of the Muntinlupa City Police should accrue to its trust liabilities fund under general funds;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panglungsod of Muntinlupa in Session assembled that:

Section 1. Increase the Police Clearance fee under Section 93 (a), (b), (c), (d), Article IV, Chapter II, Title IV of Ordinance No. 02-076 to PhP120.00 based on a 60% - 40% share of the Muntinlupa City Police to accrue directly to its trust liabilities fund created for police operations and other expenses and;

Section 2. Increase the Police Clearance fee under Section 93 (e) to PhP260.00 based on a 60% - 40% sharing in favor of the City Government, with the 40% share of Muntinlupa City Police to accrue directly to its trust liabilities fund created for police operations and other expenses;

Section 3. Any ordinance, resolution or rules inconsistent with the provisions of this ordinance is hereby repealed or modified accordingly;

Section 4. This ordinance shall take effect immediately upon approval.

ENACTED, by the Fourth (4^{th}) Sangguniang Panlungsod of Muntinlupa this 5^{th} day of May 2005, on its 34^{th} Regular Session.
