WHEREAS, City Ordinance No. 02-047 adopted the Zoning Guidelines and Regulations for the City Of Muntinlupa;

WHEREAS, under Executive Order No. 71 and Republic Act 7160, otherwise known as the New Local Government Code of 1991, states that, "the power of the Housing and Land Use Regulatory Board (HLURB) to approve preliminary and final subdivision plans of all subdivisions has been transferred to the Local Government Units";

WHEREAS, Section 458 (2) (x) of the same Code states that "the Sangguniang Panlungsod has the power to process and approve land use and zoning within its jurisdiction";

WHEREAS, after evaluating the necessary documents submitted by *Britany Corporation* and based on the recommendation of the City Zoning Administrator, the application for *Alteration of Plan of Britany Corporation* is hereby approved, subject to the terms and condition under the Ordinance;

Section 2. The said lot is not part of the open space of La Posada Subdivision.

Section 3. The area subject to Alteration of Plan has not been sold and has not yet been developed.

Section 4. The area will be subdivided to 54 lots which will be sold as residential lots only.

Section 5. The existing Homeowners' Association interposes no objection to the alteration plan of La Posada Subdivision.
