AN ORDINANCE GRANTING TWO THOUSAND PESOS (P2,000.00) TO EACH RENTER AND/OR RESIDENT SALES PERSONNEL WHO WERE AFFECTED BY THE FIRE ON DECEMBER 22, 2005 AT ESPELETA COMMERCIAL BUILDING, BARANGAY POBLACION, MUNTINLUPA CITY.

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that *"The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

"(1) (iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"

WHEREAS, on **December 22, 2005**, there were eighteen (18) renters and/or resident sales personnel of Saber Enterprise, Villarica Pawnshop, Four Angels Bakery, Annie Gift Shop, Mister Donut and Corban who were affected by the fire in **Espeleta Commercial Building, Barangay Poblacion, Muntinlupa City**;

WHEREAS, the renters and/or resident sales personnel were rendered jobless by reason of the said fire;

WHEREAS, there is need for the City Government to give financial assistance to the aforesaid victims in the amount of **Two Thousand Pesos (P2,000.00) each**;

WHEREAS, there is an available fund from the Calamity Fund in the 2005 Executive Budget of the City;
