WHEREAS, on *February 24, 2005*, there were *forty one (41)* house owners, *forty (40)* house renters and *twenty seven (27)* house sharers/boarders (whose houses were totally damaged) and *nine (9)* house owners/renters/boarders (whose houses were partially damaged) who were affected by the fire in *Km. 23 West Kabulusan II, Cupang, Muntinlupa City*;

WHEREAS, the owners of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas as in a state of calamity;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the area affected by the fire last *February 24, 2005* at *Km. 23 West Kabulusan II, Cupang, Muntinlupa City* be declared as in a *State of Calamity*.
