A RESOLUTION AUTHORIZING CITY MAYOR HON. ATTY. JAIME R. FRESNEDI TO ENTER INTO A REVISED MEMORANDUM OF AGREEMENT ON THE OPERATION AND MANAGEMENT OF OSPITAL NG MUNTINLUPA BETWEEN THE CITY GOVERNMENT OF MUNTINLUPA AND OSPITAL NG MUNTINLUPA FOUNDATION, INC. TO CONFORM TO THE EXISTING RULES AND REGULATIONS OF THE COMMISSION ON AUDIT (COA).

WHEREAS, the establishment of the Ospital ng Muntinlupa (OSMUN) v one of the priority projects of the City Government of Muntinlupa intended to meet the health needs of the people, especially the poor and the underprivileged;

WHEREAS, the construction of the Ospital ng Muntinlupa was financed by a loan secured from the Land Bank of the Philippines in the amount of Two Hundred Million Pesos (P200,000,000.00) by virtue of Sangguniang Panlungsod Resolution No. 99-073 dated March 15, 1999;

WHEREAS, by virtue of the Resolution of the Pre-Bids and Awards Committee dated February 6, 2001, declaring failure of bidding for the operation and management of the Ospital ng Muntinlupa for lack of bidders, urgency to provide the health needs of the people, and considering that the City Government cannot operate the hospital without incurring huge expenses and further considering that the operation is already set for opening and in the interest of public service, the said City Government's only option was to enter into a negotiated contract with the Ospital ng Muntinlupa Foundation, Inc., a nonstock corporation that offered the services most advantageous to the City;

WHEREAS, Resolution No. 01-361, passed on March 23, 2001 on its 12th Special Session, authorizing Mayor Jaime R. Fresnedi to enter into a negotiated contract with the Ospital ng Muntinlupa Foundation, Inc. in the operation and management of the Ospital ng Muntinlupa;

WHEREAS, the Ospital ng Muntinlupa started its operation on April 27, 2001, by virtue of the Memorandum of Agreement entered into between the Ospital ng Muntinlupa Foundation, Inc. and the City Government on March, 2001;

WHEREAS, the Commission on Audit in its three (3) previous reports, pointed out that the MOA entered into by and between City Government of Muntinlupa and the Ospital ng Muntinlupa Foundation, Inc., a non-stock, non-profit foundation for the latter to operate and mange the said hospital was not in accordance with Article 30 of the Rules and Regulations Implementing the Local Government Code of 1991:

WHEREAS, the Memorandum of Agreement and operation of the Ospital ng Muntinlupa entered into between Ospital ng Muntinlupa Foundation, Inc. and the City Government needs to be reviewed in order to conform with COA rules and regulations;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, to authorize *City Mayor Hon. Atty. Jaime R. Fresnedi* to enter into a Revised Memorandum of Agreement on the operation and management of Ospital ng Muntinlupa between City Government of Muntinlupa and Ospital ng Muntinlupa Foundation, Inc. to conform to the existing rules and regulations of the Commission on Audit (COA). The revised Memorandum of Agreement adheres to the existing rules and regulations of the Commission on Audit in compliance with the existing laws and regulations covering all government transactions.

This Resolution shall take effect immediately upon its approval.
