WHEREAS, the owners of the houses, renters, and sharers were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas as in a state of calamity;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the area affected by the fire last *March 28, 2005* at *7C PNR Site, Alabang, Muntinlupa City* be declared as in a *State of Calamity*.


