WHEREAS, Section 15 of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that "Every local government unit created or recognized under this Code is a body politic and corporate endowed with the powers to be exercised by it in conformity with law";

WHEREAS, Section 22 (a) of the same Code states that "Every local government unit, as a corporation, shall have the powers xxx to acquire and convey real or personal property and enter into contracts xxx";

WHEREAS, Section 22 (c) of the same Code further provides that "Unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned.";

WHEREAS, *Metro Bank* has been occupying a property in Barangay Alabang owned by the City Government of Muntinlupa;

WHEREAS, the total area being used by said bank is 256.50 square meters more or less;

WHEREAS, Metro Bank and the City Government of Muntinlupa that Mayor Jaime R. Fresnedi had a previous five-year contract of lease which started on January 01,1999 and which expired on December 31, 2003, with a monthly rental of One Hundred Thirty Four Thousand Nine Hundred Thirty Six Pesos and Fifty Centavos (P134,936.500);

WHEREAS, *Metro Bank* is interested to continue leasing and has offered to enter into a *new contact of lease* with the City of Muntinlupa for a period of *five (5) years* to *commence* on *January 01, 2004* and *expire* on *December 31, 2008*;

WHEREAS, considering that the business sector has remained sluggish, a one (1) year moratorium on the increase in monthly rental shall be implemented;

WHEREAS, the escalation clause shall begin to be implemented on the second (2^{nd}) year continuing up to the fifth (5^{th}) year with a five percent (5%) annual increase in the monthly rental;

WHEREAS, *Metro Bank* has offered to pay the City Government the following rental;

January 01, 2004 to December 31, 2004- P134,936.50, per month; January 01, 2005 to December 31, 2005- P141,683.35, per month; January 01, 2006 to December 31, 2006- P148,767.50, per month;

January 01, 2007 to December 31, 2007- P156,205.85, per month;

January 01, 2008 to December 31, 2008- P164,016.15, per month;

WHEREAS, Metro Bank shall advance the amount of Eight Hundred Nine Thousand Six Hundred Nineteen Pesos (P809,619.00) representing six (6) months deposit which is refundable at the end of the term of the contract and another Eight Hundred Nine Thousand Six Hundred Nineteen Thousand Pesos (P809,619.00) as advance rental for six (6) months, or a total of One Million Six Hundred Nineteen Thousand Two Hundred Thirty Eight Pesos (1,619,238.00) upon signing of the lease contract;

RESOLVED, THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod authorizing City Mayor Atty. Jaime R. Fresnedi to enter into contract of lease with Metro Bank as represented by its Senior Executive Vice President, Henry M. Sun for the use of a property in Barangay Alabang owned by the City Government of Muntinlupa.
