WHEREAS, there is a budget appropriated for Garbage Collection and Disposal Services amounting to **Sixty-One Million Two Hundred Thirty-One Thousand Seven Hundred Sixty-One Pesos and 62/100 (p61,231,761.62)**.

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVE,** by the Sangguniang Panlungsod of Muntinlupa, further extending the Contract of REN Transport Corporation for garbage collection and disposal services for two months (April To May 2005), amounting to **Six Million Eight Hundred Three Thousand Five Hundred Twenty-Nine Pesos & 07/100 (P6,803,529.07) per month** and authorizing the City Mayor Atty. Jaime R. Fresnedi, to enter into a contract in behalf of the City Government.






