A RESOLUTION AUTHORIZING THE HON. CITY MAYOR, ATTY. JAIME R. FRESNEDI TO ENTER INTO A NEW CONTRACT IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH REN TRANSPORT CORPORATION IN GARBAGE COLLECTION AND DISPOSAL SERVICES FROM JUNE 1, 2005 TO FEBRUARY, 2006 IN THE AMOUNT OF SIXTY-ONE MILLION TWO HUNDRED THIRTY-ONE THOUSAND SEVEN HUNDRED SIXTY-ONE PESOS AND 62/100 (P61,231,761.62).

**WHEREAS**, the Public Bidding for garbage collection and disposal services was conducted last 14 April 2005;

**WHEREAS**, on 18 April 2005, the Bids and Awards Committee issued a resolution declaring REN Transport Corporation as the bidder with lower calculated and lower bid for the garbage collection and disposal services;

**WHEREAS**, the REN TRANSPORT CORPORATION won the Public Bidding conducted last 14 April 2005 in the amount of SIXTY-ONE MILLION TWO HUNDRED THIRTY-ONE THOUSAND SEVEN HUNDRED SIXTY-ONE PESOS AND 62/100 (P61,231,761.62) for the garbage collection and disposal services and the contract was awarded last May 13, 2005;

**WHEREAS**, the City Government of Muntinlupa thru the Bids and Awards Committee advertised the Invitation to apply for Eligibility and to Bid of the Garbage Collection and Disposal Services in a newspaper of general nationwide circulation and posted the same in the City Government of Muntinlupa website, the G-EPS and conspicuous place at the premises of the City Government continuously for fourteen (14) days;

**WHEREAS**, in response to the said advertisements, nine (9) contractors submitted letters of intent and applications for eligibility but only One (1) was found eligible on 28 March 2005;

**WHEREAS**, only one bid was submitted on April 14, 2005 and passed the preliminary examination of bids;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder with the lowest calculated bid, its bid has been found to be responsive;

**WHEREAS**, the approved budget for the contract is Sixty Nine Million Five Hundred Eighty Nine Four Hundred Twelve Pesos and 82/100 (P69,589,412.82);

**WHEREAS**, there is a budget appropriated for Garbage Collection and Disposal Services amounting to Sixty-One Million Two Hundred Thirty-One Thousand Seven Hundred Sixty-One Pesos and 62/100 (P61,231,761.62)

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVE**, by the Sangguniang Panlungsod of Muntinlupa, authorizing the Hon. City Mayor, **Atty. Jaime R. Fresnedi** in behalf of the City Government of Muntinlupa to enter into a new contract with **REN Transport Corporation** in garbage collection and disposal services from **June 01, 2005 to February 2006** in the amount of **Sixty-One Million Two Hundred Thirty-One Thousand Seven Hundred Sixty-One Pesos and 62/100 (p61,231,761.62)**.


