A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI TO UTILIZE THE CALAMITY FUND 2005 EXECUTIVE BUDGET FOR RELIEF, RECONSTRUCTION, REHABILITATION AND OTHER WORKS AND SERVICES IN CONNECTION WITH THE STATE OF CALAMITY DECLARED UNDER RESOLUTION NO. 05-145 IN THE AMOUNT OF SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (P7,500,000.00)

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that "***The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall:***

"(1) (iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"

WHEREAS, on **September 16, 2005**, there were **Eighth Hundred Fifty Nine (859)** families who were affected by the flash floods along the bay areas within Muntinlupa City;

WHEREAS, the houses of said families were rendered flooded by reason of the said flash floods;

WHEREAS, there is need for the City Government to allocate funds in the amount of **Seven Million Five Hundred Thousand Pesos (P7,500,000.00)** as a precondition to the use of a calamity fund for undertaking disaster activities including relief, reconstruction, rehabilitation and other works and services and to implement measures that will mitigate or prevent the occurrence of flash floods or calamity in the City of Muntinlupa, to be distributed as follows:

b. Coco Lumber	- 1,500,000.00;
c. Medicines and other medical supplies	- 1,000,000.00;
d. Relief Goods (Social Services Department)	- 500,000.00;
e. Rescue Equipments (Muntinlupa Disaster and Coordinating Council)	- <u>1,500,000.00.</u>
TOTAL	- P7,500,000.00

WHEREAS, The *Social Services Department* of the City has submitted a certified copy of the list of the families in coordination with the Barangay Chairman of Alabang, Cupang, Buli, Sucat, Bayanan, Putatan, Poblacion and Tunasan and is made an integral part of this Ordinance;

WHEREAS, there is an available fund from the Calamity Fund in the 2005 Executive Budget of the City;

NOW THEREFORE, BE IT ENACTED, by the Members of the Sangguniang Panlungsod in session duly assembled to authorize the City Mayor Hon. Jaime R. Fresnedi to utilize the Calamity Fund 2005 Executive Budget for relief, reconstruction, rehabilitation and other works and services in connection with the State of Calamity declared under Resolution No. 05-145, in the amount Seven Million Five Hundred Thousand Pesos (P7,500,000.00).
