A RESOLUTION INCREASING THE NUMBER OF FAMILIES AFFECTED BY THE FLASH FLOODS ON SEPTEMBER 16, 2005 ALONG THE BAY AREAS OF THE CITY OF MUNTINLUPA UNDER RESOLUTION NO. 05-145 AND RESOLUTION NO. 05-146, FROM EIGHT HUNDRED FIFTY NINE (859) TO ONE THOUSAND EIGHT HUNDRED FIFTY NINE (1,859) FAMILIES, AND APPROPRIATING THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P200,000.00) FOR THIS PURPOSE TO BE TAKEN FROM THE 2005 CALAMITY FUND.

WHEREAS, on *September 16, 2005*, there were *Eight Hundred Fifty Nine (859)* families who were affected by the flash floods along the bay areas of the *City of Muntinlupa* and the subject of relief assistance in *Resolution No. 05-145* and *Resolution No. 05-146*;

WHEREAS, there is a surmounting number of flash floods victims unaccounted during the *9<sup>th</sup> Special Session*, and therefore a need to address the need for additional relief aid;

WHEREAS, *Mrs. Analyn A. Mercado, Acting Head* of the *Social Service Department (SSD)*, through a letter dated *September 26, 2005* requested for an assistance of rice and grocery items to be given to the additional *1,000 families* who were likewise affected by the flash floods along the bay areas of the *City of Muntinlupa*;

WHEREAS, said additional number of families were recommended by the *Barangay Captains* of the *eight (8) barangays* within the *City of Muntinlupa*;

RESOLVED THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled increasing the number of families affected by the flash floods on *September 16, 2005* under *Resolution No. 05-145* and *Resolution No. 05-146*, from *Eight Hundred Fifty Nine (859)* to *One Thousand Eight Hundred Fifty Nine (1,859)* families, and appropriating the amount of *Two Hundred Thousand Pesos (P200,000.00)* for this purpose to be taken from the *2005 Calamity Fund*.


