WHEREAS, the project was awarded to *D.L. Cervantes Construction* being the lowest bidder for the *construction of Gymnasium* located at *Barangay Tunasan, Muntinlupa City*;

WHEREAS, the approved agency estimate of the contract for the project is P74,729,010.23;

WHEREAS, the Bids and Awards Committee (BAC) pursuant to the provisions of *Republic Act 9184* and the legal opinion given by the *Office of the City Attorney* citing *Section 37 paragraph 2 of Republic Act 9184*, *Section 37.3*, *Section 38, 38.1* and *38.2* of the same *Act* saw no need to seek authority from the *City Council* prior to entering into a contract;

WHEREAS, pursuant to Section 76 of RA 9184 states that "Any other law, presidential decree or issuance, executive order, letter of instruction, administrative order, proclamation, charter, rule or regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

**WHEREAS**, however, to further enhance transparency and accountability the *BAC* submitted the contract for ratification to the *City Council*;

**WHEREAS**, based on the reports and documents submitted by the *BAC* to the *Committee on Engineering*, *Public Works and Infrastructure*, the said project has undergone due process for procurement and contracting for infrastructure project pursuant to *RA 9184*;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, ratifying/confirming the contract entered into by the City Mayor Hon. Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa with D.L. Cervantes Construction for the project construction of Gymnasium located at Barangay Tunasan, Muntinlupa City in the amount of P74,726,487.90 to be taken from the Infrastructure Projects under the 2005 Executive Budget.


