WHEREAS, Section 458 (a) (1) (f) (iv) of the Local Government Code of 1991 states that "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall:

"(f) (iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events."

WHEREAS, on November 5, 2005 there were Fifty Five (55) fish cage operator affected by fish kill incident along the bay areas of Barangay Tunasan, Muntinlupa City that suffered a loss of approximately 33 tons of fish;

WHEREAS, the fish kill incident in the bay areas along Barangay Tunasan had resulted into a loss of income and livelihood for the fish cage operators;

WHEREAS, the Lake Management Office (LMO) recommended to declare the affected areas as in a state of calamity;

RESOLVED THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the areas affected by the fish kill along the bay areas of Barangay Tunasan, Muntinlupa City last November 5, 2005, be declared as in a **State of Calamity**.




