AN ORDINANCE **APPROVING** THE **REQUEST** OF SAMAHANG MAGKAKAPITBAHAY NG BAYANAN PUROK 4. MUNTINLUPA HOMEOWNERS ASSOCIATION, INC., TO BORROW THREE MILLION PESOS (Php 3,000,000.00) FOR THE PURCHASE OF THE SIX THOUSAND FIVE HUNDRED THIRTEEN (6,513) SQUARE METERS LOT, MORE OR LESS, COVERED BY TCT NO. 148238 REGISTERED IN THE NAMES OF JOVITA CARLOS, SERGIO CARLOS, VICTORIA CARLOS, GREGORIO CARLOS AND QUIRICO CARLOS LOCATED AT PUROK 4, SAN GUILLERMO ST., BAYANAN. MUNTINLUPA CITY FOR ITS HOUSING PROJECT THROUGH THE NATIONAL HOME MORTGAGE FINANCE CORPORATION (NHMFC) WHICH AMOUNT SHALL BE TAKEN FROM 2006 EXECUTIVE BUDGET.

WHEREAS. the Samahang Pinagpalang Magkakapitbahay Bayanan, Purok IV, Muntinlupa Homeowners Association, Inc., is seeking loan assistance from the City Government of Muntinlupa in the amount of Three Million Pesos (Php3,000,000.00) to purchase a lot in Bayanan for its housing project the release of the money from the NHMFC;

WHEREAS, the City Administrator endorsed to the City Council the application of Samahang Pinagpalang Magkakapitbahay ng Bayanan, Purok IV, Muntinlupa Homeowners Association, Inc., for Interim Financing Assistance in the amount of Three Million Pesos (Php3,000,000.00);

WHEREAS, the parcel of land is situated at Purok 4. San Guillermo St., Bavanan, City of Muntinlupa with TCT No. 148238 containing an area of Six Thousand Eight Hundred One (6,801) square meters;

WHEREAS, the selling price of a parcel of land is Two Thousand Pesos (Php 2,000.00) per square meters in the total amount of Thirteen Million Twenty Six Thousand Pesos (P13,026,000.00);

WHEREAS, the owner agrees to sell a portion of the subject property consisting of (6,513) square meters only, to Samahang Pinagpalang Magkakapitbahay ng Bayanan, Purok 4, Muntinlupa Homeowners Association, Inc., which shall be paid through the Community Mortgage Program (CMP) of the National Home Mortgage Finance Corporation (NHMFC) for the purpose of subdividing the same as residential lots exclusively for its urban poor members;

**WHEREAS**, the land owner requested the association to pay additional advance payment of the total purchase price of the subject property in the amount of *Three Million Pesos* (*P3*,000,000.00);

**WHEREAS**, the association has requested the *City Government of Muntinlupa* for a loan assistance in the amount of *Three Million Pesos* (*P3*,000,000.00) from the *City's Interim Financing Facility* for *Socialized Housing Program*;

**WHEREAS**, the association agreed to execute a *Deed of Assignment* and *Memorandum of Agreement* that once the *NHMFC* releases the check(s) in payment of the loan granted by the *City* for the purchase price of the lot, said / payment shall be given to the *City Government* as payment of the loan granted to the association;

**WHEREAS**, the association agreed to directly pay the monthly amortization to the *City Government* and make the lot as security for the loan in the event that the *NHMFC* is unable to release the payment of the lot;

**WHEREAS,** there is a fund available under the 2006 Executive Budget of the City Government;

**NOW BE IT ORDAINED AS IT IS HEREBY ORDAINED**, by the City Council of Muntinlupa in session assemble the following terms and conditions:

1. The **VENDOR** shall execute a **Deed of Absolute Sale** in favor of the ASSOCIATION, conveying an area of Six Thousand Five Hundred Thirteen (6,513) square meters of the subject property to the **Association** in the amount of Two Thousand Pesos (Php2,000.00) per square meters or in the aggregate amount of Thirteen Million Twenty Six Thousand Pesos (Php13,026,000.00) upon full payment thereof;

- The VENDOR shall execute a corresponding Deed of Assignment in favor of the City Government assigning a portion of the CMP proceeds of the Association as payment for the aggregate amount of Three Million Pesos (Php3,000,000.00) advanced by the City to the Association and paid by the latter to the VENDOR;
- The VENDOR shall pay the corresponding amount of transfer tax, documentary stamp tax on sale and other incidental expenses such as registration fees, documentary stamps and other payments regarding the purchase of the said property;
- 4. The **ASSOCIATION** shall faithfully comply with the necessary documentary requirements on *CMP* set forth by the *NHMFC* with the assistance of the *City* as their originator;
- 5. The **ASSOCIATION** shall require the qualified beneficiaries/members to undertake the *Saving Mobilization Program* being implemented by the *City*;
- 6. The **ASSOCIATION** shall pay the real property tax and other expenses, apart from the amount committed by the landowner that may be incurred in the process of issuance of the new title;
- The ASSOCIATION shall facilitate the exemption of the landowner from paying the Capital Gains Tax from the Bureau of Internal Revenue and Transfer Tax from the VENDOR;
- 8. The CITY shall advance the amount of Three Million Pesos (P3,000,000.00) to the VENDOR, representing the additional advance payment of the property being purchased by the ASSOCIATION for the later;

The **CITY** shall provide the necessary assistance to the **ASSOCIATION** in the resettlement of its members, in coordination with *Philippine Business* for Social Progress (PBSP) as partner funding institution.

RESOLVED, THERFORE, AS IT IS HEREBY RESOLVED, to approve the request of the of Samahang Magkakapitbahay ng Bayanan Purok 4, Muntinlupa Homeowners Association, Inc., to borrow Three Million Pesos (Php 3,000,000.00) for the purchase of the six thousand five hundred thirteen (6,513) square meters lot, more or less, covered by TCT No. 148238 registered in the names of Jovita Carlos, Sergio Carlos, Victoria Carlos, Gregorio Carlos and Quirico Carlos located at Purok 4, San Guillermo St., Bayanan, Muntinlupa City for its housing project through the National Home Mortgage Finance Corporation (NHMFC) which amount shall be taken from the 2006 Executive Budget.
