AN ORDINANCE ABOLISHING THE POSITION OF ASSISTANT DEPARTMENT HEAD III UNDER THE CITY HEALTH OFFICE.

WHEREAS, Section 458 (a) (VIII), of the Local Government Code of 1991, provides that, "the Sangguniang Panlungsod shall determine the positions, salaries, wages and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government";

WHEREAS, Article 99, of Implementing Rules and Regulations of the Local Government Code of 1991, provides that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city xxx";

WHEREAS, Article 163, of Republic Act 7160, otherwise known as the Implementing Rules and Regulations of the Local Government Code of 1991, provides that, "the Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its priority needs, service requirements, and financial capabilities consistent with the principles on simplicity, efficiency, economy effectiveness, dynamism and public accountability subject to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC)";

WHEREAS, Article 164(a), of the same Code, provides that, "any Local Government Unit may reorganize through the Sanggunian its present organizational structure or alter its present staffing pattern in accordance with laws pertinent to government reorganization and implementing rules and regulations xxx";

WHEREAS, as per organizational structure in any Department there is only one Assistant Department Head;

WHEREAS, the position of City Government Department Head III with item No. 02-2 has been vacant for so long;

WHEREAS, the Personnel Department of the City is in favor that it should be abolished so that a new and much needed position can be created and filled up;

WHEREAS, Dra. Magdalena C. Meana, Department Head of City Health Office, recommends that the budget for the said position can be use for creation of two or more positions that may contribute to the success of the department;

NOW, THEREFORE BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod in session assembled that:

SECTION 1. This ordinance hereby abolishes the position of Assistant Department Head III under the City Health Office.

SECTION 2. *Implementing Guidelines* -The City Health Office shall formulate its Implementing Rules and Regulations (IRR) for the creation of new positions in lieu of the abolished position and shall submit its staffing pattern in the City Personnel Office for its approval.

SECTION 3. Separability Clause – If any portion of this ordinance is declared invalid, the remainder of this ordinance shall not be affected by such declaration and shall remain valid and enforceable.

SECTION 4. *Repealing Clause* – All ordinances, rules and regulations or parts thereof where provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. *Effectivity.* This ordinance shall take effect upon its approval.
