AN ORDINANCE GRANTING THREE THOUSAND PESOS (P3,000.00) TO EVERY HOMEOWNER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND TWO THOUSAND PESOS (P2,000.00) TO EACH RENTER, SHARER/BOARDER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND ONE THOUSAND PESOS (P1,000.00) TO EACH HOMEOWNER AND RENTER (WHOSE HOUSE WAS PARTIALLY DAMAGED), AND THREE THOUSAND PESOS (P3,000.00) TO A CHILD INJURED BY THE FIRE ON FEBRUARY 14, 2006 AT #210 FANTASTIC, SITIO RIZAL, BARANGAY ALABANG MUNTINLUPA CITY.

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that "The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall:

"(1) (iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"

WHEREAS, on February 14, 2006, there were fourteen (14) house owners three (3) house renters and one (1) house sharer/boarder (whose houses were totally damaged); three (3) house owners and three (3) house renters (whose houses were partially damaged); and one (1) child injured, who were affected by the fire in #210 Fantastic, Sitio Rizal, Barangay Alabang, Muntinlupa City:

WHEREAS, there is an available fund from the Calamity Fund in the 2006 Executive Budget of the City;

NOW THEREFORE, BE IT ENACTED, by the Members of the Sangguniang Panlungsod in session duly assembled "GRANTING THREE THOUSAND PESOS (P3,000.00) TO EVERY HOMEOWNER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND TWO THOUSAND PESOS (P2,000.00) TO EACH RENTER, SHARER/BOARDER (WHOSE HOUSE WAS TOTALLY DAMAGED), AND ONE THOUSAND PESOS (P1,000.00) TO EACH HOMEOWNER AND (WHOSE RENTER HOUSE WAS **PARTIALLY** DAMAGED), AND THREE THOUSAND PESOS (P3,000.00) TO A CHILD INJURED BY THE FIRE ON FEBRUARY 14, 2006 AT #210 FANTASTIC, SITIO RIZAL, BARANGAY ALABANG, MUNTINLUPA CITY".
