WHEREAS, the 1987 Philippine Constitution states that "the State shall protect and promote the right to health of the people and instill health consciousness among them" and "the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods and other social services available to all people at affordable cost":

WHEREAS, the Local Government Code of 1991 is very emphatic that local government units shall endeavor to be self-reliant and shall have health services, which include the implementation of programs and projects on primary health care, maternal and child care and communicable and non-communicable diseases, access to secondary and tertiary services;

WHEREAS, pursuant to the above provisions of the Constitution and of Local Government Code, and the dream of the City Government in establishing for its constituents a comprehensive health services, the OSPITAL NG MUNTINLUPA (OSMUN) was established at the Civic Center, Filinvest Corporate City, Barangay Alabang, Muntinlupa City;

WHEREAS, one of the eight-point programs of the City Government is the Health Care Program for the constituents of the City especially the underprivileged;

WHEREAS, the Ospital ng Muntinlupa was established in March 2001 the centerpiece and flagship program of the City Government under the leadership of Hon. Mayor Atty. Jaime R. Fresnedi for year 2001;

WHEREAS, the contract of the Ospital ng Muntinlupa Foundation shall expire on March 31, 2006;

WHEREAS, for purposes of ensuring the smooth and orderly turn-over and transfer of the operation and management of the Hospital to the City Government, the Hon. Mayor Jaime R. Fresnedi has signed Executive Order No. 03, Series of 2006, creating the Oversight Committee for the Ospital ng Muntinlupa, defining its functions and composition;

WHEREAS, to set the overall direction of the Hospital as a public tertiary medical institution dedicated to the delivery of quality health care and services to the less privileged members of the community, the City Government of Muntinlupa shall adopt the following statement of mission and vision for the Ospital ng Muntinlupa;

WHEREAS, the mission to be adopted is:

"The Ospital ng Muntinlupa is committed to deliver accessible, affordable and humane total quality health care and services within the financial resources of the City Government, through committed, competent and compassionate health care professionals and workers. It shall partner with all sectors in the promotion and provision of optimum health care services for residents of Muntinlupa and other communities";

WHEREAS, the vision to be adopted is:

"The Ospital ng Muntinlupa envisions to be one of the best sustainable centers of wellness in the Philippines";

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD, adopting the mission and vision of the City of Muntinlupa for the Ospital ng Muntinlupa (OSMUN).

ADOPTED, by the Fourth (4<sup>th</sup>) Sangguniang Panlungsod of Muntinlupa this 9<sup>th</sup> day of March, 2006, on its 71<sup>st</sup> Regular Session.
