AN ORDINANCE AUTHORIZING THE CITY MAYOR HON, ATTY, JAIME R. FRESNEDI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH PROFESSOR BERNARD LEO M. KARGANILLA OF THE UNIVERSITY PHILIPPINES-MANILA REGARDING THE UNDERTAKING OF THE FIRST MANAGEMENT COMMUNICATIONS PROGRAM FOR THE **PUBLIC EXECUTIVES** AND TERTIARY-LEVEL **PUBLIC EDUCATORS OF** MUNTINLUPA AND APPROPRIATING FUNDS THEREFOR.

WHEREAS, he has also the qualifications and experience to undertake the First Management Communications Program for the Public Executives and Tertiary-Level Public Educators of Muntinlupa;

WHEREAS, the City Government has agreed to the proposal and has sufficient available appropriations for the purpose;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa in session assembled that the parties have hereunto agreed to the following terms and conditions:

SECTION 1. Title of the Project – The title of the project is the "First Management Communications Program for the Public Executives and Tertiary level Public Educators of Muntinlupa."

SECTION 2. Brief description of the research and extension activities. The Second Party shall undertake the provision of and guidance for lectures and presentation, information-education materials, and a certificate of completion to the public executives and tertiary level public educators of Muntinlupa who successfully and satisfactorily participated in and completed the program of 2006.

SECTION 3. *Objectives.* Upon completion of the program, the participants should be able to:

- Have a better command of the English Language;
- Describe the dynamics and progression of Muntinlupa, especially in the light of its Vision 2020;
- Work individually and in groups on storyboards and presentations;
- Package a developmental idea as a proposal.

SECTION 4. *Funding support.* The City Government of Muntinlupa shall pay the amount of Three Hundred Thousand Pesos (Php300,000.00) to Prof. Bernard Karganilla to be distributed in three installments, as follows:

- Fifty Percent (50%) or Php150,000.00 before the start of the program.
- Twenty five Percent (25%) or Php75,000.00 upon completion of the series of lectures and presentations.
- Twenty five Percent (25%) or Php75,000.00 upon submission of the final report.

SECTION 5. *Duration* - The duration of the project shall be three (3) months, that is, from February to May 2006.

SECTION 6. Expected Output. The second party through the Project Director, shall run the "First Management Communications Program for the Public Executives and Tertiary-Level Public Educators of Muntinlupa."

SECTION 7. The Second Party shall provide the project with competent lecturers who have expertise in their particular subject and/or field.

The Second Party shall provide the project relevant SECTION 8. information-education materials.

SECTION 9. The Second Party shall fulfill the objectives of the project.

SECTION 10. The Second Party shall award the Certificate of Completion to all participants who satisfactorily completed at least seventy-five percent (75%) of all the sessions and submit the requirements of the project.

SECTION 11. The First Party shall provide the venue and the facilities for all the sessions and shall ensure the religious and registered attendance of the selected participants in the project.

SECTION 12. The parties shall jointly evaluate the project upon completion.

SECTION 13. Publication and Dissemination. The Second Party shall have the right of first refusal in the publication of final report within the first (1st) year after the termination of project. During this period, the Second Party has the privilege to publish the results, in part or in full, of the project. All properties belong to the Second Party.

SECTION 14. Ownership of Project output and intellectual property rights. Both parties have the right to use all data and findings produced by virtue and pursuant to this agreement for the enhancement of their academic or official functions and research program. The rights to innovative discoveries, royalties and other intellectual property rights that may arise from the activities undertaken in the pursuit of this agreement shall be governed by the pertinent provisions of the Intellectual Property Rights Code of 1998, the DOST Memorandum Circular No. 001, Series of 1998, and the University of the Philippines Board of Regents Resolutions on Policies, Rules and Regulations governing Patentable and Copyrightable Works of 1985 and other relevant legislations.

SECTION 15. Changes in the Project. Substantive changes in the project shall be made in writing and shall take effect only upon the mutual approval of the two parties.
