

ORDINANCE NO. 06-087

AN ORDINANCE AUTHORIZING AND APPROVING THE OPERATION AND MANAGEMENT OF THE OSPITAL NG MUNTINLUPA BY THE OVERSIGHT COMMITTEE, CREATED BY VIRTUE OF EXECUTIVE ORDER NO. 03 SERIES OF 2006 OF THE HONORABLE CITY MAYOR ATTY. JAIME R. FRESNEDI, PRESCRIBING THE RATES OF HOSPITAL CHARGES AND FEES TO BE IMPOSED AND COLLECTED THEREAT, AND FOR OTHER PURPOSES.

WHEREAS, the 1987 Philippine Constitution states that "the State shall protect and promote the right to health of the people and instill health consciousness among them" and "the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods and other social services available to all people at affordable cost";

WHEREAS, the Local Government Code of 1991 is very emphatic in stating that local government units shall endeavor to be self-reliant and shall have health services, which include the implementation of program and project on primary health care, maternal and child care and communicable and noncommunicable diseases, access to secondary and tertiary health services;

WHEREAS, pursuant to the above provisions of the Constitution and of Local Government Code, and the dream of the City Government in establishing for its constituents a comprehensive health services, the OSPITAL NG MUNTINLUPA ("Hospital" for brevity) was established at the Civic Center, Filinvest Corporate City, Barangay Alabang, Muntinlupa City;

WHEREAS, on 27 March 2001, the City Government, through the Honorable Mayor Jaime R. Fresnedi entered into a Memorandum of Agreement (MOA) with the OSPITAL NG MUNTINLUPA FOUNDATION, INC. for the operation and management of the Hospital for a period of five (5) years;

WHEREAS, the contract with the Ospital ng Muntinlupa Foundation shall expire on March 31, 2006, without any agreement for renewal or extension;

WHEREAS, for purposes of ensuring the smooth and orderly turn-over and transfer of the operation and management of the Hospital to the City Government, the Hon. Mayor Jaime R. Fresnedi has signed Executive Order No. 03, Series of 2006, creating the Oversight Committee for the Ospital ng Muntinlupa, defining its functions and composition;

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD, IN SESSION ASSEMBLED that the operation and management of the Ospital ng Muntinlupa by the Oversight Committee, created pursuant to Executive Order No. 03 Series of 2006, of the Hon. City Mayor Atty. Jaime R. Fresnedi, is hereby AUTHORIZED, APPROVED, CONFIRMED and RATIFIED, subject to the following provisions:

Section 1. The Oversight Committee is tasked to oversee and perform general supervision and control over the operation and management of the Hospital, its facilities, personnel, properties, and finances, pursuant to the mandate of Executive Order No. 03 Series of 2006, for a fixed period of one (1) year beginning 01 April 2006, unless otherwise sooner replaced, dissolved, or supplanted by the Honorable City Mayor.

1.a. The Composition of the Oversight Committee created pursuant to Executive Order No. 03 Series of 2006, shall include the City Treasurer.

Section 2. As a lawful incident of the operation of the Hospital, it is hereby authorized to collect reasonable hospital fees and charges, based on the schedule indicated below, which shall be strictly implemented and shall remain in force and effect unless otherwise modified or amended, in accordance to the provisions of the Muntinlupa City Revenue Code:



II. ROOM RATES. Present rates will be retained but subject for review by the Oversight Committee.

III. OUTPATIENT CLINICS

Accredited Doctors are allowed practice at the Out Patient clinics. The following rates shall apply:

P300.00 for consultant; P400.00 for sub-specialist;

The Doctors will pay P100.00 per hour for the use of the space and for payment of utilities. This will be subject for review of the Oversight Committee.

Ophthalmologists and other specialists who bring in their instruments and machines shall bill the hospital for the use of their machines on a monthly basis. This will be subject for review by the Oversight Committee.

NOTATION:

- 1. Computed rates are inclusive of Philhealth, KKK subsidy.
- 2. Anesthesiologist Fee 40 % of the Surgeon's Fee.
- 3.a.) For multiple related simultaneous procedure, ONLY the procedure with the highest computed value will be paid.
 - b) However, a separate, related, independent procedures done simultaneously are charged individually and separate of each other.
 - c) Procedures done at different time intervals are charged separately.
- 4. For procedures requiring first and second assists, only the surgeon may charge based on the above-rates. Assist CANNOT charge for the procedure.
- 5. If a patient needs a prolonged stay (7 days), the surgeon may charge a daily visit rate (after the 7th hospital day) based on that provided for medicine and pediatrics. However, the anesthesiologist's professional fee should be based ONLY on the procedures value and should NOT include the daily visit rate.
- 6. Above rates are ceiling rates. A physician may opt to give discounts per physician's discretion.
- 7. The hospital will follow any change in the RUV of the PHILHEALTH of any procedures.
- 8. The multiplier, however, shall be approved by the Sangguniang Panlungsod upon recommendation of the Oversight Committee.
- 9. A patient seeking admission to the ward but due to unavailability of room and urgency of his condition he was admitted to the semi-private room; patient will be charged the professional rates stipulated for the ward, the patient needs to be transferred to the ward the soonest possible time after the room becomes available.
- 10. The City Government shall pay the professional fees of the doctors within 15 to 30 days after discharge of the patients.

NOTE: The new Professional Fees rates supersede the previous rates, however, the Room rates, Laboratory fees, and other fees and charges shall remain enforced subject for review by the Oversight Committee.

Section 3. All payments of Hospital fees and charges shall be supported by official receipts of the City Government to be issued by a duly authorized officer of the City Treasurer's Office.
