ORDINANCE NO. 06-090

AN ORDINANCE GRANTING THREE THOUSAND PESOS (P3,000.00) TO EVERY HOUSEOWNER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND TWO THOUSAND PESOS (P2,000.00) TO EACH RENTER, SHARER, BOARDER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND ONE THOUSAND PESOS (P1,000.00) TO EACH HOUSEOWNER, RENTER, SHARER, BOARDER (WHOSE HOUSE WAS PARTIALLY DAMAGED) BY THE FIRE ON APRIL 22, 2006 AT PUROK 2, PNR SITE, BARANGAY SUCAT, MUNTINLUPA CITY.

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that "The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances *xxx* and appropriate funds for the general welfare of the city and its inhabitants *xxx* and shall":

"(1) (iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events:"

WHEREAS, on *April 22, 2006*, there were eighteen (18) house owners, nine (9) house renters and five (5) house sharers/boarders (whose houses were totally damaged); one (1) house owner, two (2) house renters and three (3) house boarders (whose houses were partially damaged), who were affected by the fire in *Purok 2, PNR Site, Barangay Sucat, Muntinlupa City*;

WHEREAS, the house owners, renters and sharers/boarders were rendered homeless by reason of the said fire;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in a state of calamity:

WHEREAS, there is need for the City Government to give financial assistance to the aforesaid victims in the amount of Eighty Eight Thousand Pesos (P88,000.00) to be distributed as follows:

WHEREAS, the Social Services Department (SSD) of the City has submitted a certified copy of the list of the homeowners, renters, sharers and boarders (totally and partially damaged) in coordination with the Barangay Chairman of Sucat, Hon. Rafael T. Sevilla and is made an integral part of this Ordinance;

WHEREAS, there is an available fund from the Calamity Fund in the 2006 Executive Budget of the City:

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED. by the Sangguniang Panlungsod in session duly assembled to grant Three Thousand Pesos (P3,000.00) to every houseowner (whose house was totally damaged), Two Thousand Pesos (P2,000.00) to each renter, sharer/boarder (whose house was totally damaged and One Thousand Pesos (P1,000.00) to each houseowner, renter, sharer/boarder (whose house was partially damaged) by the fire on April 22, 2006 at Purok 2, PNR Site, Barangay Sucat, Muntinlupa City.

ENACTED, by the Fourth (4th) Sangguniang Panlungsod Muntinlupa this 27th day of April 2006, on its 75th Regular Session.
