AN ORDINANCE AMENDING NO. 05-040, THEREBY EXTENDING THE PERIOD OF ACCREDITATION OF NON-GOVERNMENT, PEOPLE'S AND OTHER ORGANIZATIONS.

**WHEREAS**, the Federation of United People's Organization in Danger Areas of Muntinlupa City (FUPODA) submitted a resolution requesting to extend to five (5) years the period of renewal of accreditation of non-government organizations and people's organizations and not only one (1) year as presently provided under Section 6 of Ordinance No. 05-040;

**WHEREAS**, the reason cited by FUPODA in its resolution is that it has to spend more time in preparing the necessary documents which are not quite easy to produce;

**WHEREAS**, the representatives of Urban Poor Affairs Office (UPAO), Cooperative Office and Community Development Affairs Office interpose no objection to the extension of the period of renewal of accreditation;

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod in session assembled that:

**SECTION 1.** Ordinance No. 05-040, Section 6, which provides for the period coverage of accreditation read as follows:

*"The organization duly accredited by the Sangguniang Panlungsod shall enjoy the privileges of an accredited organization for one (1) year from the time the Chief Executive signs the ordinance for accreditation and shall be renewable annually. The organization applying for renewal shall submit its application two (2) months prior to the expiration of its accreditation."*

shall be amended by extending the period from one (1) year to three (3) years, provided that:

- i) The organization must still submit on an annual basis a copy of its annual report to the Securities and Exchange Commission (SEC), or a copy of the annual report to the HLURB or Cooperative Development Authority or whatever national agency which requires submission of annual reports.
- ii) The organization must still submit the annual or biennial report as the case may be, of the results of the elections of its new set of officers or board of directors.
- iii) The organization must still submit an annual financial report and annual accomplishment report as required by the Ordinance.


**SECTION 2.** No two or more non-governmental or people's organizations shall be accredited which have the same members thereof to avoid duplication. In the same manner, no organization shall be accredited when it has two or more set of officers.


**SECTION 3.** All organizations accredited prior to the passage of this ordinance shall be extended to three years from the time the Chief Executive approved their respective accreditations.


**ENACTED,** by the **Fourth (4<sup>th</sup>) Sangguniang Panlungsod of Muntinlupa** this **22<sup>nd</sup>** day of **June, 2006** on its **80<sup>th</sup>** Regular Session.






