AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 IN THE AMOUNT OF SEVENTY ONE MILLION THREE HUNDRED THIRTY SIX THOUSAND SIX HUNDRED NINE PESOS AND 81/100 (PHP71,336,609.81) TO BE TAKEN FROM THE RETAINED FUND OF THE CITY.

WHEREAS, in accordance with Section 319 of R.A. 7160, otherwise known as the New Local Government Code of 1991, the Sangguniang Panlungsod of Muntinlupa passed an Ordinance enacting the Annual Budget Ordinance on the basis of the estimates of income and expenditures submitted by the Local Chief Executive;

WHEREAS, the said budget has taken effect at the beginning of the current fiscal year;

WHEREAS, Section 321 of the same Code in part, states that "No ordinance providing for a supplemental budget shall be enacted except when supported by funds actually available as certified by the Local Treasurer or by new revenue sources;

WHEREAS, Hon. Jaime R. Fresnedi has submitted a proposed Supplemental Budget No. 3 dated May 5, 2006 in the amount of Seventy One Million Three Hundred Thirty Six Thousand Six Hundred Nine Pesos and 81/100 (Php71,336,609.81);

WHEREAS, City Treasurer Nelia A. Barlis has certified that the source of the income shall come from the retained earnings/surplus funds of the city;

WHEREAS, the Budget Officer has prepared a statement of supplemental budget appropriations for the City of Muntinlupa;

WHEREAS, the concerned offices signed the said Supplemental Budget No. 3 and recommended its approval by the City Council;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Panglungsod in session assembled that:

SECTION 1. The Supplemental Budget No. 3 is hereby approved in the amount of Seventy One Million Three Hundred Thirty Six Thousand Six Hundred Nine Pesos and 81/100 (Php71,336,609.81) to be taken from the retained earnings/surplus funds of the city..

SECTION 2. The amount of the Supplemental Budget No. 3 amounting to Seventy One Million Three Hundred Thirty Six Thousand Six Hundred Nine Pesos and 81/100 (Php71,336,609.81) shall be taken from the retained earnings/surplus fund of the city which shall be appropriated as follows:

Sec. 2-A. Infrastructure Projects:

- a) **Buildings**; Construction of Covered Courts (change order) Katarungan Village Phase 2 - Php479,054.04, RMT Subdivision, Tunasan - Php478,297.44, Rizal Village Alabang - Php490,686.00, Camella Homes 2, Putatan - Php482,236.80, Camella Homes 2E, Putatan - 477,693.72, Sto. Niño Village Phase 4 - Php477,882.24, Don Juan Bay View Sucat - Php491,681.28, Victoria Homes, Tunasan - Php499,539.48, Baywalk, Bautista St., Ext. Bayanan - Php1,500,000.00, Extension of Business Permit and Licensing Office - Php10,000,000.00, Construction of Muntinlupa Renewal Homes, Bautista St., Bayanan - Php15,000,000.00.
- b) **Other Structures** (Provision of Street Railing and Widening of Pavement, Tunasan Landfill Site - Php4,500,000.00; Construction of Retaining Wall Additional Works/Change Order, Bautista St., Ext. Bayanan - Php 2,035,718.93; Road/Parking Concreting (Sports Complex) - Php15,000,000.00);
- c) **Artesian Wells** (Submersible water pump, Posadas Subdivision, Sucat - Php1,300,000.00, Various Barangays - Php2,000,000.00);

d) **Electrification** - Street lighting, Buli Proper amounting to Php1,273,819.88, Other Infrastructure Projects amounting to Php2,000,000.00;

Sec. 2-B. Manpower Development Center - Equipment/Tools amounting to One Million Pesos (Php1,000,000.00).

Sec. 2-C. Special Activities Fund - Land Banking amounting to Ten Million Pesos (Php10,000,000.00), Special Projects (SK and ABC President) amounting to Six Hundred Thousand Pesos (Php600,000.00).

Sec. 2-D. Public Information Office, Other Maintenance and Operating Expenses amounting to Six Hundred Fifty Thousand (Php650,000.00).

SECTION 3. This ordinance shall take effect upon its approval.


