WHEREAS, Section 192 and 458 (a) (2) (xii) of *Republic Act 7160*, otherwise known as the *Local Government Code of 1991* provides that: "*Local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary*";

WHEREAS, on July 17, 2006, **Mr. Omar Guerrero**, Head, *Singles' Ministry of Christ's Commission Fellowship*, a non-stock and non-profit entity located at Prime Park Building, Prime Corner Enterprise Streets, Madrigal Business Park, Alabang, Muntinlupa City sought the approval of the **City Mayor Atty. Jaime R. Fresnedi**, thru the *Sangguniang Panlungsod* for tax exemption of its inspirational concert entitled "**Rocking God's House**" to be held at the 4<sup>th</sup> Floor of CCF Alabang's Main Worship Hall on August 25, 2006;

WHEREAS, said inspirational concert shall feature artists, *Rockstеды and Barbie Almalbis* who will present their original compositions of their musical album, and in addition, will be providing the rock/alternative and soulful rhythm and beat to each musical number;

WHEREAS, the target audience of 1,600 will be mostly single men and women professionals as well as the youth teenagers coming from Parañaque, Muntinlupa, Lower Laguna and Cavite;

WHEREAS, the proceeds of the said concert shall go to the Singles' Ministry's "**Sponsor One for Christ Project**", a retreat which aims to introduce Jesus Christ to the first-timers and eventually to discipline them to Christian maturity;

WHEREAS, the **Singles' Ministry of Christ's Commission Fellowship** shall, within thirty (30) days after the date of the event, submit to the BPLO and the City Council proof of income and donation of the event;

NOW THEREFORE, BE IT ENACTED BY THE SANGGUNIANG PANLUNGSOD OF MUNTINLUPA IN SESSION ASSEMBLED, to grant **exemption of amusement tax** to **Singles' Ministry of Christ's Commission Fellowship** on its inspirational concert entitled "**Rocking God's House**" to be held at the 4<sup>th</sup> Floor of CCF Alabang's Main Worship Hall, Prime Park Building, Prime Corner Enterprise Streets, Madrigal Business Park, Alabang, Muntinlupa City on August 25, 2006.


