WHEREAS, there is an available fund from the Calamity Fund in the 2006 Executive Budget of the City;

WHEREAS, typhoon Milenyo caused floods, loss of shelters, lives, properties, injuries and other calamities that require clearing out operations, rehabilitation of damaged properties and evacuation of more or less 1,264 families or 3,966 persons;

NOW THEREFORE, BE IT ORDAINED by the 4th Sangguniang Panlungsod in session duly assembled allocating Fifteen Million Pesos (Php15,000,000.00) as assistance to the victims of calamity, purchase of equipments for clearing out operations and rehabilitation of damaged properties, medicines and other related expenses caused by Typhoon Milenyo to be taken from the Calamity Fund..
