AN ORDINANCE APPROPRIATING THE AMOUNT OF FIFTY TWO MILLION NINE HUNDRED THIRTY FOUR THOUSAND EIGHT HUNDRED TWENTY FOUR PESOS AND 31/100 (PHP52,934,824.31) AS SUBSIDY FOR THE OPERATION OF THE OSPITAL NG MUNTINLUPA TO BE TAKEN FROM THE AVAILABLE UNAPPROPRIATED BALANCE OF THE RETAINED OPERATING SURPLUS.

WHEREAS, in view of the turn-over of the operation and management of the Ospital ng Muntinlupa to the City Government last 01 April 2006, a Supplemental Budget in the amount of EIGHTY FIVE MILLION PESOS (PHP85,000,000.00) has been approved by the Sangguniang Panlungsod for the period April to December 2006;

WHEREAS, the Ospital ng Muntinlupa has requested for additional budgetary allocation to finance and sustain its continuous operation as a tertiary, 150-bed capacity hospital and deliver adequate medical and hospital care services to the constituents of the City of Muntinlupa and the general public;

WHEREAS, City Budget Officer Avelino A. Orellana has prepared a statement of supplemental appropriations for the Ospital ng Muntinlupa in the amount of FIFTY TWO MILLION NINE HUNDRED THIRTY FOUR THOUSAND EIGHT HUNDRED TWENTY FOUR PESOS AND 31/100 (PHP52,934,824.31), to come from the additional income generated by the Ospital ng Muntinlupa, which was approved by the Local Chief Executive;

WHEREAS, section 321 of the Local Government Code, in part, states that: "No ordinance providing for a supplemental budget shall be enacted except when supported by funds actually available as certified by the Local Treasurer or new revenue sources.";

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Muntinlupa that the Supplemental Budget for the subsidy of the Ospital ng Muntinlupa, in the amount of **FIFTY TWO MILLION NINE HUNDRED THIRTY FOUR THOUSAND EIGHT HUNDRED TWENTY FOUR PESOS AND 31/100 (PHP52,934,824.31)**, to come from the additional income generated by the Ospital ng Muntinlupa, is hereby **APPROVED**, to take effect immediately.


