**WHEREAS**, Section 458 (a) (VIII) of the Local Government Code of 1991 provides that, "*the Sangguniang Panlungsod is empowered to determine the positions, salaries, wages and other emoluments and benefits of officials and employees, paid wholly or mainly from the city funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the city government*";

**WHEREAS**, Article 99 of the Implementing Rules and Regulations of the Local Government Code of 1991, provides that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city";

**WHEREAS**, Article 163 of R.A. 7160, otherwise known as the Implementing Rules and Regulations of the Local Government Code of 1991, provides that, "the Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its priority needs, service requirements and financial capabilities, consistent with the principles of simplicity, efficiency, economy, effectiveness, dynamism and public accountability subject to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC)";

**WHEREAS**, Article 164 (2) of the same Code, provides that, "any Local Government Unit may reorganized through the Sanggunian its present organizational structure or alter its present staffing pattern in accordance with laws pertinent to government reorganization and implementing rules and regulations";

**WHEREAS**, as per the present organizational structure of the City Accounting Office, the positions of Accounting Clerk I (SG-4) and Accountant I (SG-11) have long been vacant due to its corresponding salary grade, which is no longer commensurate with the level of educational attainment required of the positions;

**WHEREAS**, with the end in view of enhancing the effective delivery of service in the City Accounting Office, it is deemed necessary to eliminate inactive positions, in lieu of which, create certain plantilla positions which is more responsive to the manpower requirements of the office;

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED**, by the Sangguniang Panglungsod in session duly assembled the following:

Section 1. This Ordinance shall be known as "an Ordinance for the abolition and creation of certain plantilla positions in the City Accounting Office, appropriating funds for the compensation of personnel to be assigned thereat and for other purposes.

Section 2. **Positions to be abolished.** For the purpose of this Ordinance, the position of Accounting Clerk I with salary grade (SG-4) and basic annual compensation of P78,264.00 and that of an Accountant I, with salary grade (SG-11) and basic annual compensation of P126,420.00, is hereby abolished.

Section 3. **Creation of plantilla positions.** In lieu of the abolished positions as provided for under Section 2 hereof, the following plantilla positions, with the corresponding salary grade, basic annual compensation and item required by the City Accounting Office is hereby created, to wit:

Section 4. **Appropriation.** For the basic annual compensations of personnel who will fill-up the plantilla positions as herein-above created, the amount of Seven Hundred Eighty Nine Thousand Three Hundred Eighty Four Pesos (P789,384.00), is hereby appropriated, which amount shall be taken from the general fund of the City Government.

Section 5. **Implementing Guidelines.** The City Personnel Office is hereby mandated to strike out from its record the abolished positions and shall see to it that the plantilla positions as herein created for the City Accounting Office is in accordance with the qualifications standard of the Civil Service Commission and in conformity with the existing policy of the Department of Budget and Management.

Section 6. **Separability Clause.** If any portion of this Ordinance is declared invalid, the remainder of this Ordinance shall not be affected and shall remain valid and enforceable.

Section 7. **Repealing Clause.** All ordinances, rules and regulations or part thereof where provisions are in conflict or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


Section 8. **Effectivity.** This Ordinance shall take effect upon its approval.
