**WHEREAS**, Section 18 of Republic Act 7160, otherwise known as the Local Government Code of 1991 states that:

Local Government Units xxx; **to create their own sources of revenue and to levy taxes, fees and charges which shall accrue exclusively for their use and disposition and which shall be retained by them;**

**WHEREAS**, the Department of Trade and Industry (DTI) will re-launch the fast and easy registration through the "**On-Line Business Trade Name**" registration;

**WHEREAS**, the City Government of Muntinlupa will provide a business friendly environment, entered into a Memorandum of Agreement with the Department of Trade and Industry to facilitate the issuance of business trade name through the "**On-Line Business Trade Name**" registration;

**WHEREAS**, the City Government of Muntinlupa will provide all the equipments and manpower to operate the "**On-Line Business Trade Name**" registration;

**WHEREAS**, to be able to compensate the expenses of the City Government of Muntinlupa in the operation of the DTI "**On-Line Business Trade Name**" registration, a **fee** is hereby imposed in the amount of **Fifty Pesos (Php50.00)** which will accrue to the City Government of Muntinlupa;






