AN ORDINANCE GRANTING ADDITIONAL ALLOWANCE OF ONE THOUSAND PESOS (P1,000.00) EACH TO THE CONSULTANTS OF MAYOR'S OFFICE, VICE-MAYOR'S OFFICE AND SANGGUNIAN PANLUNGSOD RESEACHERS, TEAM LEADERS AND MEMBERS OF KABALIKAT, JOINT RESOURCES FOR FAMILY PROGRAM (JRF), RURAL IMPROVEMENT CENTER FOR CHILDREN (RICC), BARANGAY HEALTH WORKERS, MEMBERS OF BRASS BAND AND MEMBERS OF DANCE COMPANY.

WHEREAS, under the *Local Government Code of 1991*, as amended, the Sangguniang Panlungsod has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from City funds;

WHEREAS, there are **2,457** employees qualified to be given productivity pay under AO 161, out of the total work force of 4, 021 employees;

WHEREAS, the application for this payment is based on the two preceding semesters and qualification is based on employees hired on or before January 3, 2005;

WHEREAS, there are **1,126** exemptions as follows: *Consultants (59) Sangguniang Panlungsod Reseachers (131), Kabalikat (642), JRF (18), RICC (6), Barangay Health Workers (216), City Band (36) and Dance Company (18);*
