RESOLUTION RECOGNIZING THE **LEGAL EXISTENCE ESTABLISHMENT** OF **BAGONG** SILANG **ELEMENTARY** SCHOOL (FORMERLY BAGONG SILANG ELEMENTARY SCHOOL ANNEX), LOCATED AT SITIO BAGONG SILANG, BARANGAY SUCAT, MUNTINLUPA CITY AND ENDORSING THE SAME FOR APPROVAL OF THE HIGHER AUTHORITY OF THE DEPARTMENT OF EDUCATION (DepEd).

WHEREAS, Article II, Section 17of the Philippine Constitution states that "The State shall give priority to education, xxx, accelerate social progress, and promote total human liberation and development";

WHEREAS, Article XIV, Section 2 (1) of the Philippine Constitution also provides that "The State shall establish, maintain, and support a complete. adequate, and integrated system of education relevant to the needs of the people and society";

WHEREAS, the name Bagong Silang Elementary School was conceived by the civic spirited citizens headed by late Mrs. Lulu Teodoro in 1987. It was originally an outreached of Benedictine Abbey School with one (1) makeshift room. Three years after, another four (4) makeshift rooms were constructed from 384 square meters through the initiative of the then Mayor Ignacio "Toting" R. Bunye, now the Press Secretary. It was then renamed Sucat Elementary School Annex;

WHEREAS, to accommodate the rapid population growth and to cater the right for education of every school-aged child, the City Government of Muntinlupa through City Mayor Atty. Jaime R. Fresnedi, purchased the right to use a parcel of land consisting of 949.20 square meters in the amount of P800,000.00 for the establishment of an extension school site and the construction of the school building which was funded by CAŞPAR Foundation;

WHEREAS, at present, Bagong Silang Elementary School offers a complete elementary school with one thousand two hundred twenty two (1,222) pupils. It has nineteen (19) nationally-paid teachers, eleven (11) city-paid teachers, fourteen (14) non-teaching personnel and three (3) barangay volunteers. It has a total of sixteen (16) classrooms which encompasses the four (4) makeshift rooms, the two-storey building with six (6) classrooms and the three-storey building with six (6) classrooms;

WHEREAS, the *Bagong Silang Elementary School* now has a separate budget allocation from the National Office like other schools in the Division;

WHEREAS, the Bagong Silang Elementary School has met the prescribed requirements as stipulated in **Memorandum Circular No. 12**, s. 2003 and Chapter II Section 2 & 4 of DECS Service Manual 2000;

WHEREAS, to protect and promote the right of the City's children to quality education, it is imperative upon the higher authority of the *Department of Education (DepEd)* to accredit/approve the legal existence and establishment of *Bagong Silang Elementary School* without further delay;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa in session assembled to recognize the legal existence and establishment of *Bagong Silang Elementary School* (Formerly Bagong Silang Elementary School Annex), located at Sitio Bagong Silang, Barangay Sucat, Muntinlupa City and to endorse the same for approval of the higher authority of the *Department of Education (DepEd)*.
