A RESOLUTION DECLARING THE AREAS AFFECTED BY THE FISH KILL ON JUNE 5, 2006 ALONG THE BAY AREAS OF BARANGAY BULI, MUNTINLUPA CITY AS IN A STATE OF CALAMITY.

WHEREAS, Section 458 (a) (1) (iv), of the Local Government Code of 1991, states that "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall:

"(1) (iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events."

WHEREAS, on June 5, 2006, there were Forty Six (46) individual persons from Samahan ng mga Maliliit na Mangingisda ng Buli (SAMAMAB) and from the members of Samahang Sikap Purok-2 were affected by the fish kill incident along the bay areas of Barangay Buli, Muntinlupa City that suffered a loss of approximately 4-6 tons;

WHEREAS, the fish kill incident in the bay areas along Barangay Buli had resulted into a loss of income and livelihood for the fish cage operators;

WHEREAS, the affected fishes are tilapia and big head carp, cultured inside fish cages;

WHEREAS, the Lake Management Office (LMO) recommended to declare the affected areas as in a "state of calamity";




