AN ORDINANCE APPROPRIATING THE AMOUNT OF NINETY THOUSAND PESOS (Php90,000.00) FOR FAMILIES AFFECTED BY THE FIRE ON APRIL 27, 2007 AT FREEWILL SUBDIVISION, PUTATAN, CITY OF MUNTINLUPA WHICH AMOUNT SHALL BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER CALAMITY FUND.

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall":

(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on April 27, 2007, there were five (5) house owners (totally damaged) and four (4) (partially damaged); one (1) house renters (totally damaged) and four (4) (partially damaged); five (5) house sharers/boarders (totally damaged) that were affected by the fire in Freewill Subdivision, Putatan, Muntinlupa City;

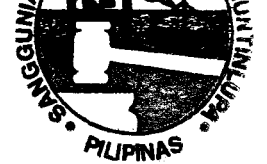
WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in **a state of calamity**;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims: in the amount of Thirty Five Thousand Pesos (Php 35,000.00) to be distributed as follows:

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod duly assembled to appropriate the amount of **Ninety Thousand Pesos (P90,000.00)** for families affected by the fire on **April 27, 2007** at **Freewill Subdivision, Putatan, City of Muntinlupa** which amount shall be taken from the 2007 Executive Budget under Calamity Fund.
