AN ORDINANCE APPROPRIATING THE AMOUNT FORTY TWO THOUSAND PESOS (Php42,00.00) FOR FAMILIES AFFECTED BY THE FIRE ON MAY 12, 2007 AT ST. MARY ST., JPA SUBDIVISION, TUNASAN, CITY OF MUNTINLUPA WHICH AMOUNT SHALL BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER CALAMITY FUND

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall":

(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on May 12, 2007, there were seven (7) house owners (whose houses were totally damaged) that were affected by the fire in St., Mary St., JPA Subdivision, Tunasan, Muntinlupa City;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in **a state of calamity**;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims: in the amount of Forty Two Thousand Pesos (Php 42,000.00) to be distributed as follows:
