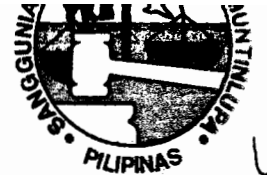

ORDINANCE NO. 07- 004

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOUR HUNDRED TWENTY NINE THOUSAND PESOS (Php429,000.00) FOR FAMILIES AFFECTED BY THE FIRE ON JULY 22, 2007 AT RESIDENTIAL BLOCK 35 (LIKOD) SOLDIER'S HILLS VILLAGE, PUTATAN, CITY OF MUNTINLUPA WHICH AMOUNT SHALL BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER CALAMITY FUND.

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on July 22, 2007, forty six (46) homeowners whose houses were totally damaged, sixteen (16) renters whose houses were totally damaged, eighteen (18) sharer/boarder/s whose houses were totally damaged, one (1) house owner whose house was partially damaged and three (3) persons with minor laceration were affected by the fire in Residential Block 35 (Likod) Soldier's Hills Village, Putatan, Muntinlupa City;

WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in **a state of calamity**,

WHEREAS, the 5th Sangguniang Panlungsod passed a Resolution No. 07-004, "A resolution declaring the area affected by the fire on July 22, 2007 at Block 35 (Likod) Soldiers' Hills Village, Barangay Putatan, Muntinlupa City, as in a state of calamity";

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims in the amount of **Four Hundred Twenty Nine Thousand Pesos** (Php 429,000.00) to be distributed as follows:

WHEREAS, the Social Services Department (SSD) of the City has submitted a certified copy of the list of the homeowners, renters, sharer/boarders (totally damaged and partially damaged) in coordination with the Barangay Chairman of Putatan **Hon. Danilo R. Teves** is made an integral part of this ordinance;

WHEREAS, there is an available fund from the Calamity Fund in the 2007 Executive Budget of the City;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod duly assembled to appropriate the amount of **Four Hundred Twenty Nine Thousand Pesos (P429,000.00)** for families affected by the fire on July 22, 2007 at **Residential Block 35 (Likod) Soldier's Hills Village, Putatan, City of Muntinlupa** which amount shall be taken from the 2007 Executive Budget under Calamity Fund.

ENACTED, by the 5th Sangguniang Panlungsod of Muntinlupa this 27th day of **July 2007**, on its 1ST **Special Session**.
