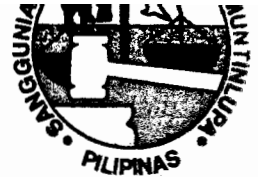

AN ORDINANCE APPROPRIATING THE SUM OF FIFTY FIVE MILLION PESOS (Php55,000,000.00) FOR THE REBUILDING AND RESTORATION OF THE MAIN BUILDING OF CITY HALL OF MUNTINLUPA CITY TO BE TAKEN FROM THE 2007 EXECUTIVE BUDGET UNDER CALAMITY FUND OF THE CITY.

WHEREAS, Section 458 (a)(l)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall,*

"(l)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events".

WHEREAS, on **August 3, 2007**, at around 11:40 am, a fire started and escalated at the residential area of **Mangga St., Lakeview Homes, Putatan, Muntinlupa City**, of which seventeen (17) houses were totally damaged and six (6) houses were partially damaged that affected 23 families;

WHEREAS, the fire further escalated to the Main Building of City Hall of Muntinlupa City which was gutted and totally damaged;

WHEREAS, the fire not only razed to the ground the main City Hall building, but more so adversely affected the governance and delivery of services to the constituents of Muntinlupa City;

WHEREAS, on **August 6, 2007** the Sangguniang Panlungsod of Muntinlupa approved **Resolution No. 07-006** declaring the City of Muntinlupa as in a state of Calamity;

WHEREAS, the **City Mayor Hon. Aldrin L. San Pedro** through his letter dated **August 6, 2007** requested the City Council to give him authority to use the portion of the Calamity Fund of the City to fast track the rebuilding and reconstruction of the damaged building of the City Hall of Muntinlupa City;

WHEREAS, the **Budget Officer Mr. Avelino Orellana**, certified that more or less Sixty Million Pesos (Php60,000,000.00) under Calamity Fund is available;

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the 5th Sangguniang Panlungsod of Muntinlupa, appropriating the sum of Fifty Five Million Pesos (Php55,000,000.00) shall be taken from the 2007 Executive Budget under Calamity Fund of the City for the rebuilding and restoration of the Main building of City Hall of Muntinlupa City.

ENACTED, by the 5th **Sangguniang Panglungsod of Muntinlupa** this 6th day of **August 2007**, on its 5th **Regular Session**.


