**WHEREAS, Article 99 (iv), of the Local Government Code of 1991, Implementing Rules and Regulations, provides that, the Sangguniang Panlungsod as legislative body of the city, shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and relative thereto, shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and the aftermath of said disasters or calamities and their return to productive livelihood following said events;**

**WHEREAS, on August 3, 2007, at around 11:40 am, a fire started and escalated at the residential area of Mangga St., Lakeview Homes, Putatan, Muntinlupa City, of which seventeen (17) houses were totally damaged and six (6) houses were partially damaged that affected 23 families;**

**WHEREAS, the Social Services Department (SSD) recommended to declare the affected area as in a state of calamity;**

**WHEREAS, the fire further escalated to the Main Building of City Hall of Muntinlupa City which was gutted and totally damaged;**

**WHEREAS, the fire not only razed to the ground the main City Hall building, but more so adversely affected the governance and delivery of services to the constituents of Muntinlupa City;**
