AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 FOR THE USE OF PAMANTASAN NG LUNGSOD NG MUNTINLUPA (PLMUN) IN THE AMOUNT OF TEN MILLION EIGHT HUNDRED THIRTY FIVE THOUSAND ONE HUNDRED FIFTY TWO PESOS AND 67/100 (PHP10,835,152.67); AND FOR OSPITAL NG MUNTINLUPA (OSMUN) IN THE AMOUNT OF THIRTY THREE MILLION THREE HUNDRED FIFTY THREE THOUSAND SIX HUNDRED SIXTY THREE PESOS AND 62/100 (PHP33,353,663.62) AMOUNTING TO FORTY FOUR MILLION ONE HUNDRED EIGHTY-EIGHT THOUSAND EIGHT HUNDRED SIXTEEN PESOS AND TWENTY NINE CENTAVOS (PHP44,188,816.29) TO BE TAKEN FROM THE GENERAL FUND OF THE CITY.

**WHEREAS**, pursuant to **Section 321** of the same Code in part, states that "**No ordinance providing for a supplemental budget shall be enacted except when supported by funds actually available as certified by the Local Treasurer or by new revenue sources**";

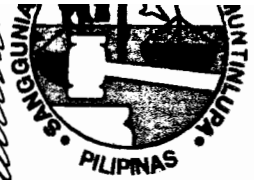

WHEREAS, pursuant to Article 99, 2(i) of *Implementing Rules and Regulations* of the same code, the Sangguniang Panlungsod, "shall approve the annual and supplemental budget of the city government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;

WHEREAS, the *City Mayor Hon. Aldrin L. San Pedro* has submitted a proposed **Supplemental Budget No. 2** dated **July 16, 2007** in the amount of *Forty Four Million One Hundred Eighty-Eight Thousand Eight Hundred Sixteen Pesos And Twenty Nine Centavos (Php44,188,816.29 )* for the use of Pamantasan ng Lungsod ng Muntinlupa (PLMUN) and Ospital ng Muntinlupa (OSMUN);

WHEREAS, City Treasurer **Nelia A. Barlis** has certified that the source of the fund shall come from the General Fund of the city;

WHEREAS, City Budget Officer, **Mr. Avelino A. Orellana** has prepared a statement of supplemental budget appropriations for the City of Muntinlupa;

WHEREAS, the concerned offices signed the said supplemental Budget and recommended its approval by the City Council;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 5<sup>th</sup> Sangguniang Panlungsod in session assembled that:

**SECTION 1.** The **Supplemental Budget No. 2** is hereby approved in the amount of *Forty Four Million One Hundred Eighty-Eight Thousand Eight Hundred Sixteen Pesos And Twenty Nine Centavos (Php44,188,816.29 )* to be taken from the General Fund of the City.

**SECTION 2.** The amount of the **Supplemental Budget No. 2** shall be distributed as follows:

<b>Ospital Ng Muntinlupa (OSMUN)</b>	<b>Php33,353,663.62</b>

**SECTION 3.** This ordinance shall take effect upon its approval.


