**WHEREAS**, pursuant to **Section 319** of R.A. 7160, otherwise known as the New Local Government Code of 1991, provides that, "**Legislative authorization of the budget - on or before the end of the current fiscal year, the Sangguniang Panlungsod of Muntinlupa shall enact, through an ordinance, the annual budget of the Local Government Unit for the ensuing fiscal year on the basis of the estimates of income and expenditures submitted by the Local Chief Executive**";

**WHEREAS**, the said budget has taken effect at the beginning of the current fiscal year;

**WHEREAS**, pursuant to **Section 321** of the same Code in part, states that "**No ordinance providing for a supplemental budget shall be enacted except when supported by funds actually available as certified by the Local Treasurer or by new revenue sources**";

**WHEREAS**, pursuant to **Article 99, 2(i)** of **Implementing Rules and Regulations** of the same code, the Sangguniang Panlungsod, "**shall approve the annual and supplemental budgets of the city government and appropriate funds for specific programs, projects, services and activities of the city, or for other purposes not contrary to law, in order to promote the general welfare of the city and its inhabitants;**

WHEREAS, City Treasurer **Nelia A. Barlis** has certified that the source of the income shall come from the General Fund of the city;

WHEREAS, City Budget Officer, **Mr. Avelino A. Orellana** has prepared a statement of supplemental budget appropriations for the City of Muntinlupa;

WHEREAS, the concerned offices signed the said supplemental Budget and recommended its approval by the City Council;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 5<sup>th</sup> Sangguniang Panglungsod in session assembled that:

**SECTION 1.** The **Supplemental Budget No. 3** is hereby approved in the amount of **One Hundred Sixty Three Million, One Hundred Sixty Thousand One Hundred Sixty Five Pesos and 96/100 (Php163,160,165.96)** to be taken from the General Fund of the City.
