AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 IN THE AMOUNT OF ONE BILLION FIVE HUNDRED MILLION PESOS (PHP1,500,000,000.00) TO BE TAKEN FROM THE APPROVED RESOLUTION NO. 07-016 ENTITLED, "A RESOLUTION AMENDING RESOLUTION NO. 07-008 AUTHORIZING THE CITY MAYOR HON. ALDRIN L. SAN PEDRO TO SECURE OR OBTAIN A LOAN IN THE AMOUNT OF ONE BILLION FIVE HUNDRED MILLION PESOS (PHP1,500,000,000.00) FROM REPUTABLE BANKING AND FINANCIAL INSTITUTION FOR THE CONSTRUCTION OF A NEW CITY HALL OF MUNTINLUPA AT A NEW SITE IN ALABANG AND OTHER INFRASTRUCTURE PROJECTS".
